

SPA Regulation

For the comfort and safety of its Guests, Boticas Hotel ART&SPA establishes the following rules and prohibitions:

- *The SPA is open every day between 9 am and 12 am;*
- *The SPA has a capacity for 10 users, simultaneously;*
- *Access to the SPA is subject to availability and prior reservation at Reception;*
- *Customers with access to the SPA, included in the stay, have access for 45 minutes per day;*
- *The SPA Circuit includes: heated pool, sauna, Turkish bath and jacuzzi;*
- *Children aged between 3 and 11 years old can use the indoor pool only if accompanied and under the supervision of an adult;*
- *Access to the jacuzzi, Turkish bath and sauna is prohibited, for security reasons, to minors under 16 years of age;*
- *It is not allowed, also for safety reasons, to run, jump, dive and use floating or inflatable objects in the pool;*
- *Accessories needed to visit the SPA: bathing suit or bikini, swimming trunks, swimming cap and flip-flops;*
- *Boticas Hotel ART&SPA provides bathrobe (rental, upon payment of €5 for each use), bath towel (for a deposit of €20 per towel, one per day, this amount will be refunded upon return of the towel), flip-flops with a price of €15 (pair), a women's bathing suit with a price of €10 (unit), men's swimming trunks with a cost of €10 (unit) and a cap with a cost of €5 € (unit);*
- *In the swimming pool it is mandatory to use a cap and conventional bathing suits. A previous shower is suggested;*
- *In the SPA facilities it is not allowed to circulate or remain without clothes;*
- *The use of cell phones for telephone conversations is prohibited, and all electronic devices must be kept absolutely silent;*
- *The use of cell phones for telephone conversations is prohibited, and all electronic devices must be kept in absolute silence; • The use of radios or any other devices that emit sound is prohibited;*
- *Guests must converse in a low tone of voice during their stay at the SPA, in order to maintain calm, silence and allow all users to relax;*
- *It is not allowed to film or photograph;*
- *It is not allowed to eat or smoke in the SPA facilities;*
- *The use of watches, jewelry or other valuables is not recommended;*
- *The use of the SPA is prohibited for Guests who are under the influence of alcohol, drugs or other toxic substances;*
- *Guests who disturb the environment, which is intended to be calm and relaxed, may be invited to leave the SPA facilities;*
- *The Hotel does not assume any responsibility for constraints or accidents resulting from misuse or non-compliance with regulations and safety rules.*



Treatments and Therapies:

- *The Boticas Hotel SPA offers several Treatments and Therapies that must be booked in advance, at Reception, and are subject to schedule availability;*
- *After confirmation of booking of Treatments and Therapies, in case of withdrawal, 50% of the value is charged;*
- *You must arrive at Reception 10 minutes prior to the scheduled time for any Treatment and/or Therapy.*
